## HAPPY NEW YEAR

The Woodwinds Board would like to wish everyone a happy new year. Now that the holidays are over, we are returning to continuing the work of improving Woodwinds.

We conducted a much-needed overhaul of our financial holdings and have maximized our earning potential with respect to our reserve accounts. Unspent money from the 2008 budget has accrued interest, providing a modest increase in our accounts, which was used to offset a necessary fee increase for 2009. This increase ranged from \$1 to \$6 and represents a 2% increase, well below the cost of living increase and increases of other communities.

In 2009 the board will continue to focus on erosion, landscaping, and water leaks, which represent the most important and most noticeable improvements to be made.

We look forward to continuing our progress and invite you to join any of the standing committees (Communications, Covenants, Landscape, Maintenance, and Parking) to help us achieve our shared goal of making Woodwinds a community of choice in Reston.

## PARKING AT WOODWINDS

The board is currently addressing a couple of parking related issues at Woodwinds this year. First, reserved spaces will be created for the 22 units along Green Watch Way that do not have either a carport or a reserved parking space.

Second, the parking regulations are being reviewed and will be reissued to include a more comprehensive and up-to-date list of rules regarding parking vehicles on Woodwinds property.

Finally, the Board and LMA are investigating a new parking permit process for identifying vehicles that belong to Woodwinds owners, residents, and guests.

This will involve a full re-registering activity for all vehicles. It is important that we have 100% compliance. Recently, Fairfax County police identified a vehicle parked at Woodwinds that was registered to a resident of Shadowood across the street. The fact that the police were interested in this vehicle is a sign that we need to be more vigilant about who parks in our neighborhood and report suspicious activity immediately to LMA or to the police. Please be sure to keep your vehicle securely locked at all times.

## UTILITY CLOSETS

Please remember that the utility closets are for community property only (hoses, garden tools, snow shovels, light bulbs. etc.) Residents who have stored personal items in the utility closets must remove their property by Friday, January 30, or it will be disposed of on the next trash day. Using the closets to store trash and seasonal items is not allowed even temporarily. Garbage and trash attract rodents; clothing and other items are potential fire hazards.

## RULES REMINDER

**Trash & Recycling** – Trash Pick-ups are Mondays and Thursdays. Trash may be set out no earlier than 8:00 pm the nights before and no later than 6:00 am on the mornings of pick-ups.

Recyclable materials should be set out with trash on **Thursdays only**. AAA suggests setting trash on one side of the walkway and recyclables on the opposite side of the walkway so the collectors don't have to rip open the trash bags. Alternatively, you may also use clear bags or the plastic recycling bins to assist in this process. On Windbluff Court, it is suggested that recyclables be set on the end of the sidewalk closest to South Lakes and trash be set on the opposite end.
